# **Educational System of Serbia Showed Social Irresponsibility towards the Roma Community**

The reading material for third graders, published by the printer "Klett" under the auspices of the Ministry of Education, carries a lesson under "Easy Folk Crafts" that goes: "A gypsy asked his mother: What is the longest day of the year? Those who wait for dinner without handle". The "Opre Roma" movement strongly resented the contentious content of the reading material and announced to file a complaint with the Commissioner for the Protection of Equality against the Ministry of Education and the publishing house. Roma, being a national minority of Serbia since 2002, are still called "Gypsies" in the textbook. It argued that the ethnic bias in textbooks and curricula against Roma is a common phenomenon and encourages the stereotypes and discrimination against them. The Ministry of Education refuted the allegation and said, it encourages and nurtures diversity, tolerance and mutual respect and respects for all minorities and does not show irresponsibility towards anyone, and especially not towards members of the Roma community. The Ministry's response clarified that it was not authorised to approve contents of the reading materials.

### New initiative to help Roma people in Bulgaria and Romania

An agreement, known as "ROMACT 9" between the Council of Europe and the European Union has been made to help the marginalised Roma communities in Bulgaria and Romania get access

to education, housing and employment, and promote their inclusion. The project has a budget of €1.7 million, beginning from January 2023. The Council of Europe and the EU have developed a specific framework to bring together local authorities and Roma community representatives for prioritizing issues, preparing action plans and securing the funds for projects that help Roma people. The first joint program 'Romact' was launched in 2013 and the project has so far apportioned about €140 million to fund more than 120 different projects in the two countries.

## Roma/Gypsies and Travellers Fear Missing out the Support on Energy Bills

Roma/Gypsy and Traveller groups, living at park homes or on sites in Great Britain, are appealing the government not to exclude them from the energy bills support scheme this winter. The scheme will cover the payment of total £400 to households with a domestic electricity connection between October 2022 and March 2023, with monthly payments administered by their energy supplier. Many of these householders live on sites where they do not have their own electricity contract. Additionally, there are growing concerns among the Roma/ Gypsies and Traveller groups, who rely on gas cylinders and power generator that they might miss this payment as they do not have direct contract with an energy supplier. Abbie Kirkby, the public affairs and policy manager at Friends, Families and Travellers, said, Gypsies and Travellers living on sites have long paid disproportionate prices for energy, with little choice over energy provider or tariffs and frequently having to pay additional handling changes for accessing energy.

For years, the discussion about the inflictions on Roma community like genocide of Romani families and burning of their houses by Nazi regime was taboo, as the communists refused to accept Roma as victims of Holocaust.

Forgotten Victims: The Tragic Story of Nazi Genocide against the Roma and Sinti

Centre for Roma Studies and Cultural Relations (CRSCR)- Antar Rashtriya Sahayog Parishad (ARSP) in Collaboration with Human Rights Defense International (HRDI) organized a virtual conference for commemorating Roma Holocaust Remembrance Day on the theme of "Forgotten Victims: The Tragic Story of Nazi Genocide Against the Roma and Sinti" to pay tribute to the victims and learn more about the Holocaust, and to find out ways to counter the contemporary antigypsyism on 10 August, 2022. Zameer Anwar, Senior Research Associate, CRSCR, stated that this commemorative event offers a platform for clearing out the historical amnesia and addressing the xenophobic sentiments and for raising awareness about Roma and Sinti holocaust. Shri Shyam Parande, Secretary General, ARSP said, Human Rights has been an issue for Roma Community since long. Nobody talks about the Holocaust of Roma/Sinti, though half a million of Roma were killed. Dr. Shaban Saliu (Macedonia), Ex Member of Parliament of Republic of North Macedonia and legal luminary and expert in constitutional affairs, shared his views on "Genocide of Roma in Balkan Peninsula in Historical Perspective". He pointed out the racial concept of Nazi that led to the Holocaust of Jews and Roma. Dr. Joanna Talewicz (Poland), Assistant Professor at the Institute of Ethnology and Cultural Anthropology in the University of Warsaw, spoke on "Unspoken Past, History, Memory and Education about Roma and Sinti Genocide". Mr. Iulian Stoian (Romania), Head of Public Policies Department, the National Agency for the Roma, Government of Romania, articulated his views on "Roma Deportation in Transnistria: Reconciliation with the Past and Policies of Memory in Romania". Ms. Agnes Daroczi (Hungary), Researcher and Roma Activist spoke about "The Fate of Roma during Holocaust". Mr. Orhan Tahir (Germany), Researcher, Lawyer and Political Scientist, enunciated his views on "The Impact of the Holocaust on Roma in post-war Europe". Advocate Rajesh Gogna, Secretary General at Human Rights Defense International, delivered the keynote address.
