## International Scientific Colloquium at INALCO, Paris

International Scientific Colloquium was organized by PLIDAM laboratory of the National Institute of Oriental Languages and Civilizations (INALCO), Paris on 5<sup>th</sup>& 6<sup>th</sup>Nov. 2020 on the theme of Rromani Millennium: results and prospects (1001 years in diaspora). The event was held to commemorate three very important events like World Day of the Rromani language (a UNESCO day: 5 November), O Baro Telăripen – The Great Departure (beginning of 1019 AD) and Six hundred years of attested presence of Rroms in France (August 1419). The Colloquium was inaugurated by Prof. Thomas Szende (Paris and Oxford) who underlined the importance of recent results achieved in Rromani linguistics and History, followed by keynote address, delivered by Mr. Paul de Sinety, Delegate general of the General Delegation for the French Language and the Languages of France (DGLFLF), an executive body of the French Ministry of Culture and Communication.

Eight Romani candidates fought the regional and the Senate elections in the Czech Republic. Only one Romani candidate Karel Karika from Pirate Party won Regional Assembly election. The Roma have long lacked any significant representation in Czech political map. Nobody has represented Romani community in the Parliament for 20 years.

## Zuzana Kumanová, the First Romani Woman Appointed to High Office in Slovakia

Zuzana Kumanová has been appointed State Secretary of the Ministry of Culture of the Slovak Republic. She has replaced Vladimír Dolinay who recently died in a traffic accident. Kumanová has dedicated her academic work to the culture and history of Romani people. She has paid special attention to the Holocaust victims of Roma and has been involved in activities to improve the position of Romani women. In the entire history of Slovakia, this is the first time any Romani person, whether a man or a woman, has been appointed to such a high State office.

## Romani Americans still Struggle with Discrimination

Romani American activists hope that the issue of discriminations which Romacommunity in US has been facing for decades, will finally be addressed under the new Democratic administration. Over one million Roma have been part of the diverse American ethnic mosaic for centuries. Historically, Roma people arrived in US mainly from Europe, escaping oppression and hoping for a better life. But anti-Roma sentiments followed them across the Atlantic. A study conducted by the Francois-Xavier Bagnoud Center for Health and Human Rights at Harvard University and Voice of Roma, a nonprofit organization based in California, shows the prevalence of institutional discrimination of Romain the US.

## Ukraine must End the Institutionalization of Children

As Roma childrenin disproportionately large numbers are taken into institutional care in Ukraine and throughout Europe, European Roma Rights Centre (ERRC) for over a decade has taken up the issueof over-representation of Romani kids in state care, and trying to shut down children's institutions for good. ERRC has joined a coalition of 22 organisations calling on the Ukrainian government and the European Union to act before it is too late to protect the rights and future of some of the most forgotten and left behind children.
