### Commemoration of the European Holocaust Memorial Day for Roma and Sinti in Auschwitz

Central Council of German Sinti and Roma and the Association of Roma in Poland commemorated the 80<sup>th</sup> anniversary of the execution of Roma and Sinti in Auschwitz on 2 August 2024. 4300 women, children and elderly people of the communities were forcefully sent to the gas chambers in the Auschwitz-Birkenau extermination camp on 2-3 August 1944. Speaking on the occasion, the Chairman of the Central Council of German Sinti and Roma, Romani Rose, stated that the experience of Nazi dictatorship obliged all to defend human dignity and human rights everywhere and for everyone. The President of the Polish Senate, Małgorzata Maria Kidawa-Błonska, attended the commemorative event and reminded of the slogan, what happened at Auschwitz "Never Again". In her speech, Bärbel Bas, President of Bundestag, said that she was the first senior representative of Bundestag to have travelled to Auschwitz to commemorate the worst of Germany's crimes against humanity and remember the people who were murdered there by the National Socialists.

## Roma Leaders Call for Reform of Agency for Social Inclusion in Czech Republic

The meeting of the Agency for Social Inclusion (ASZ) Monitoring Committee with civil members of the Government Council discussed the activities of ASZ on the situations of Roma community in Czech Republic. Subsequently, the Citizen members of the Government Council for Roma Minority Affairs and representatives of the RomanoNet organization issued a statement calling on the Government to suspend all decisions in regards to the future of the Agency for Social Inclusion and to start a broad public discussion about its future. As per them, insufficient involvement of Roma in decision processes has weekend effectiveness of efforts by ASZ to improve their conditions. Michal Miko, director of RomanoNet, said that the situation in socially excluded localities continued to worsen and the current approach of ASZ was not satisfactory.

## New Study into Roma Families and Children's Services in England

A lack of trust due to historic discrimination against Roma communities has damaged the relationship between Roma families and children's services in England. The report by Anglia Ruskin University, Lancaster University and the charity Law for Life casts light on an increasing number of Roma children in the care system. There were about 30 Roma children in care system in 2009, rose up to 50 in 2015 and stood at around 600 in 2023. The research noted the fear and mistrust of authorities because of their historic persecution across Europe. It also stated that the challenges faced by Roma families in their interactions with children's services were deeply rooted in experiences of historical discrimination, biases, prejudices and systemic failures in processes.

Roma Genocide: Rivesaltes, A Camp of Internment in France

About 1,400 Roma/Nomads out of a total of 17,500 persons were imprisoned in Rivesaltes and several hundred of them were deported to territories controlled by Nazi Germany in 1941-42. The Rivesaltes Camp Memorial (Pyrénées-Orientales) pays tribute to this sanguinary history on the occasion of the European Roma Holocaust Remembrance Day. The event also put up the exhibition displaying the Family Camp, dedicated to the persecution of Roma, and accompanied by songs and enriched with the conference organized to mark the moments of remembrance. Around 7,000 Roma/Nomads in France were interned in camps set up in 1941-42 by Pétain's regime of collaboration with Nazi Germany.

Roma Memory Map Showing Presence of the Roma community in America

Roma Memory Map aims at spotting the presence and history of the Roma community in South and North America, besides locating important places for Roma communities. Martin Fotta from the Institute of Ethnology of the Academy of Sciences pointed out that the number of places on Roma Memory Map would go up over time in countries like Brazil, Argentina or Canada. He added that Roma for the first time arrived America between the end of the 15th Century and the beginning of the 16<sup>th</sup> Century. He pointed out that Roma arrived in South America even before they arrived in some European countries. As per Scientists, Roma arrived in Americas in waves and the first one was during colonial rule. For example, Portugal among other countries expelled Roma to their colonies like Brazil.

The legalization process will open up a legal opportunity to improve the infrastructure in the Romani localities.

She further stated that Roma were marginalised and seen through a narrow and judgemental lens.

## Romani Language in Contact with Finnish and other Nordic Languages

Centre for Roma Studies and Cultural Relations (CRSCR)- Antar Rashtriya Sahayog Parishad (ARSP) hosted the Thirty-Fourth Virtual Lecture of its Monthly Lecture Series on 31 July 2024. The lecture was delivered by Dr. Kimmo Granqvist (Finland), Lecturer in Romani Language and Culture at the University of Helsinki, who reported the population of Roma is currently estimated to be 50,000- 100,000 in Sweden, Finland, Norway and Denmark according to the Council of Europe. There are several Romani groups like Kalderash, Lovari, Arli, Kale, etc. residing in Sweden. During 1960s-70s Roma flowing from Spain, Poland, France, Russia, Bulgaria and the former Yugoslavia arrived in Sweden, so there is a huge diversity among Roma communities. Kimmo emphasized that Romani language belonged to Indo-Aryan group of the Indo-Iranian subfamily of the Indo-European family of languages and Romani is the Indic language spoken outside India by Romani communities which originally migrated from India.
